Annexure-I

The phytosanitary requirements of necessary complying in the import of rice variety basmati polished or plied grain (*Oryza sativa*) origin and coming from India to Peru as following:

1. That the consignment should have the Phytosanitary permit of import issued by SENASA, obtained by the importer or interested, before the phytosanitary certification and shipping in the origin or coming from country.
2. The consignment should be accompanied with an official phytosanitary certificate of the origin country in which it is consigned.

2.1. Additional Declaration:

2.1.1. Product free of: *Callosobruchus chinensis*, *Trogoderma granarium*, *Oryzaephilus mercator*, *Latheticus oryzae*, *Corcyra cephalonica*, *Liposcelis entomophila*, *Liposcelis paeta*.

2.2. Fumigation treatment with:

2.2.1. Methyl Bromide (utilize one of the following doses):

32 g/m³/24h/at temperature 21°C or more; 40 g/m³/24h/at temperature from 16 to 20°C; 48 g/m³/24h/at temperature from 10 to 15°C. **OR**

2.2.2. Phosphine (utilize one of the following doses: 2g/m³/96h/ at temperature from 26 °C to more; 2g/m³/120h/at temperature 21 to 25°C; 2g/m³/144h/at temperature 16 to 20°C.

3. Packing will be new and first use, free from soil or any estrange material to the approved product. The packing must have a weight no more than 5 kilos and must be labelled with the name of the product, variety and origin country.
4. Closed Containers must be clean, free from insects and any estrange smell. The number of the seal in the containers must appear in the phytosanitary certificate of the origin country.
5. Phytosanitary inspection in the entry point of the country.
