# INVITING APPLICATIONS FOR APEDA EXPORT AWARD UNDER VARIOUS CATEGORIES FOR THE YEARS 2019-20 & 2020-21

Applications are hereby invited for APEDA Export Award under various categories for the years 2019-20 and 2020-21. The scheme details of Award, i.e., Award categories, selection criteria, application forms etc. are given at Annexure A. In this regard, it is requested to forward the following information:

- Submission of Application Form for APEDA Export Award for the years 2019-20 and 2020-21 as applicable. Further, the details should be submitted separately for each year.
- Submission of duly certified Product-wise export data in terms of FOB value in USD million for the years 2019-20 and 2020-21 in respect of APEDA Scheduled Products by Chartered Accountant on his letter head along with stamp and registration number in prescribed form.
- 3. All registered exporters are requested to file their monthly export returns for the financial years 2019-20 (April 19 March, 20) & 2020-21 (April 20 March, 21) through the online filing system using exporters' login on APEDA's website latest by 15th November, 2021. It may please be noted that export returns should be filed online with utmost care as the export returns will subsequently be verified from valid Registration-cum-Membership status online with CA certified statement of export from the shortlisted exporters for the selection of awardees. Further, export performance of ONLY APEDA SCHEDULED PRODUCTS for the relevant business entities registered under one RCMC (not for the Group of Companies) should be submitted.

- 4. The applications along with relevant information received will be screened by an Award Selection Committee constituted by APEDA and the awardees will be selected as per the norms stipulated. The decision of the Award Selection Committee will be final and binding on all the applicants.
- Incomplete applications, applications not accompanied with documentary evidence as required under the scheme and applications received late will summarily be rejected.
- 6. In case, any of the award winners denies the award after announcement/absents himself/herself from the Award function without intimation or furnishing convincing reasons, the applicant (a company or individual) may not be considered for any of the awards in future and award announced already may be cancelled.
- The decision of the Jury of Award with regard to the eligibility for the award, number of awards etc. shall be final.
- 8. The complete applications along with all the supporting documents in a sealed cover super scribing "Export Award for .......... (Category) during the period ......... (year)" and addressed to Shri S S Nayyar, General Manager, APEDA, 3rd Floor, NCUI Building, August Kranti Marg, Hauz Khas, New Delhi 110 016 to be submitted on or before 30th November, 2021, positively failing which the application will not be considered under probable names for APEDA Export Awards.
