**DECISIONS OF THE SUB COMMITTEE OF THE NATIONAL ACCREDITATION BODY (NAB)
UNDER NPOP**

The Sub Committee of the National Accreditation Body (NAB) under NPOP in its meeting held on 23.11.2023, has taken the following decisions:

Certification Bodies:

1. Accreditation of **RELIABLE ORGANIC CERTIFICATION ORGANIZATION (ROCO)** under NPOP has been suspended for one year alongwith pecuniary penalty of Rs. 5 lakhs for major non-compliances and violation of the NPOP.
2. Accreditation of **BALTIC TESTING INDIA PVT. LTD** under NPOP has been suspended for three months alongwith pecuniary penalty of Rs.5 lakhs for major non-compliances and violation of the NPOP.
3. Pecuniary penalty of Rs. 5 Lakhs imposed on **ADITI ORGANIC CERTIFICATION PVT. LTD.** for major non-compliances in the certification process under NPOP.
4. Pecuniary penalty of Rs. 5 Lakhs imposed on **SGS INDIA PVT. LTD.** for major non-compliances in the certification process under NPOP.
5. Pecuniary penalty of Rs. 2 Lakhs imposed on **CU INSPECTIONS INDIA PVT. LTD.** for major non-compliances in the certification process under NPOP.
6. Pecuniary penalty of Rs.1.5 lakhs has been imposed on **KARNATAKA STATE ORGANIC CERTIFICATION AGENCY (KSOCA)** for non-compliances and lapses in the certification process under NPOP.
7. Pecuniary penalty of Rs. 1 Lakhs imposed on **RAJASTHAN STATE ORGANIC CERTIFICATION AGENCY (RSOCA)** for non-compliances and lapses in the certification process under NPOP.
8. Warning letter to be issued to **ECOCERT INDIA PVT. LTD.** for lapses in certification process under NPOP.

Exporters:

1. Withdrawal of certification under NPOP for one year and pecuniary penalty of Rs. 5 lakhs imposed on **M/S ELITE GREEN PVT. LTD.** for major non-compliances and violation of the NPOP.
2. **M/s RPM EXIM Pvt. Ltd.** to be placed in the high-risk category for six months. As a mark of abundant precaution, its CB has been directed to conduct consignment based testing of organic sugar exported by M/S RPM EXIM PVT. LTD.
