CONDITIONS FOR IMPORTATION OF FRESH MANGO FRUITS

FROM: INDIA

- 1. Fruits should be sourced only from officially registered orchards and exported by officially registered exporters only from the Maharashtra State.
- 2. Phytosanitary treatment and certification will be done through the Agricultural and Processed Food Products Export Development Authority (APEDA) and the Indian Directorate of Plant Protection and Quarantine (DPPQS) approved packhouses.
- 3. Mango fruits should be subjected to:
- (a) **HOT WATER TREATMENT** through immersion in hot water at the water temperature and time duration regime listed below, depending on the fruit weight:
- (i) Fruits up to 500 grams- 48°C for 60 minutes
- (ii) Fruits up to 700 grams- 48°C for 75 minutes
- (iii) Fruits up to 900 grams- 48°C for 90 minutes

OR

(b) Vapour heat treatment (VHT), at a core temperature of 47.8 degrees centigrade for 20 minutes.

OR

- (c) Irradiation with a minimum absorbed dose of 400 Gy at a treatment facility approved by the relevant Indian authority
- 4. Fruits should be packed in clean standard carton boxes free of plant debris and soil and the packing houses shall have insect proof mesh on aeration holes to prevent cross infestation.
- 5. Care should be taken to avoid risk of re-infestation prior to shipment.
- 6. All treatments should be endorsed on the Phytosanitary Certificate with description of treatments.
- 7. Reduit to be informed on arrival.
