**Subject: Implementation of e-phyto by National Plant Protection Organization (NPPO) of India-reg.**


All the Officer in-Charges of Regional Plant Quarantine Stations (RPQSs) are hereby informed that NPPO, India has completed the integration of IPPC's e-phyto through its official web portal *i.e.* Plant Quarantine Management System (PQMS) and tested successfully. A specimen copy of Phytosanitary Certificate (PSC) to be generated through IPPC e-Phyto system with QR code is attached for reference as **Annexure I**. Further it is informed that there is no change in the format of existing PSC issued through existing PQMS as well as the PSC generated through IPPC e-Phyto hub, except the QR code. The e-Phyto system will be implemented *w.e.f.* 01.03.2023.

It is pertinent to mention that few Phytosanitary Certificate (PSC) issuing Authorities from State Agriculture/Horticulture Departments are issuing PSCs for the export of Grapes through HORTINET (GRAPENET) portal of APEDA. Apart from this, some of the PSC issuing Authorities from State Agriculture/Horticulture Departments are issuing PSCs without integration into PQMS. Upon implementation of e-Phyto system, the importing country NPPO's may not accept the PSCs issued in other mode, except PQMS.

In view of the above, you all are directed to take up the matter with the concerned PSC issuing Authorities of State Agriculture/Horticulture Departments under your jurisdiction and ensure their PSC issuance through PQMS, **latest by 27.02.2023** for smooth export of Agriculture trade. A compliance report in this regard should be furnished by **28.02.2023**.
