The Indonesian Quarantine Authority (IQA) presents its compliments to APEDA India. I sincerely thank you for your letter No. QCT-2015-16-000025 dated 7 April 2025, and greatly appreciate your continued efforts in ensuring compliance with Indonesia's food safety regulations.

Our appreciation also extends to APEDA for its readiness to facilitate an on-site visit in due course. In response to your inquiry, we would like to inform you that the new decree is currently undergoing the legal drafting process. The document will be formally conveyed to you upon its signature. Please kindly find attached the list of eligible laboratories proposed for inclusion in the Decree as registered laboratories. Based on our desk assessment, these laboratories have demonstrated compliance with all mandatory testing parameters—pesticide residues, heavy metals, mycotoxins, and microbiology—and possess the necessary capacity to perform the required analyses. Please be advised that, **effective 14 April 2025**, only the listed laboratories shall be authorized to issue Certificates of Analysis (CoA) for the exportation of India's Food and Food Product Origins (FFPOs) to Indonesia.

With regard to the 12 previously identified non-compliances, our technical team is in the process of reviewing all related documentation. Once the assessment is complete, we will inform you at the earliest opportunity.

Thank you for your kind attention. We look forward to continuing our valued cooperation in safeguarding food safety and trade between our countries. Please do not hesitate to reach out should you require any clarification or assistance regarding this matter. The IQA avails itself of this opportunity to renew the assurances of its highest consideration to the APEDA of India.
